As a hereditary society in South Carolina, we request your support to ensure that proactive steps are taken to protect historical monuments in the Palmetto State. South Carolinians remember and study their history, we honor our forefathers, and over the years we have erected and placed monuments and markers across the state to commemorate significant events, and significant people, in order to educate our citizens and visitors about all aspects of our state's long and honorable history.

The vandalism and illegal destruction of historical monuments and statues in other areas of the country has been largely unabated. Lawlessness must not be rewarded nor tolerated. Legislation requiring local governments to immediately repair and restore illegally removed monuments would motivate local officials to protect the monuments and encourage them to deter unruly, misguided, and malicious protestors. This type of policy appeals not only to a majority of South Carolinians, but also to most Americans. Polls conducted by Rasmussen Reports have shown support for historical monuments ranging from 69 to 88 percent over the past two years. There are very few policy issues with such widespread support.



A Meeting of the Officers and Founding Members

A Meeting of the St. Officers and Founding members of Saint Andrews Society of the Lowcountry was held on July 10, 2018, at Port Royal Landing Marina. The following Scottish Descendants were present:

Tom Wilson, President

The meeting was called to order by Mr. Wilson at somewhere near 5:00 pm.

- Tax Status Exchequer Harden presented a thickage of forms that he is in the process of filling out so
 as to provide the legal tax status for SALC. The Exchequer voiced his intent on several of the questions
 remaining on the forms, receiving the committee's appreciation for his work thus far, and approval of
 his plan going forward. The Exchequer will complete the forms and provide a copy to members of the
 committee prior to sending to the IRS.
- 2. Exchequer Harden also discussed evolving plans relative to the Scottish Games in Charleston and how SALC might encourage attendance by all members. The date of the games is November the third, and all members should note the date, and plan to attend with The Society. Preliminary plans are to travel in one or more vehicles and spend two hours (plus or minus) enjoying the festivities, learning more about the games and Scottish culture in general, and taking advantage of the opportunities for purchasing Scottish related clothing, food, and other refreshments. Further and more specific details will be submitted to the membership at a later date.
- 3. Frank Gibson reported on the Society's Robert Burns dinner, scheduled for 26 January, 2019, again at Dataw Island. Plans are well along, and Frank is and will be ably assisted by Col. St. Clair.
- 4. Caroll Crowther reported that (in co ordination with Founding Member/Advisor Wayne Cousar) we are moving ahead with our plans for a "Kirkin of the Tartans" service, partnering with St. Helena's Anglican Church. The planned location is Old Sheldon Church. The group is working on a date which, when determined, will be provided to the membership.

NOTE: In this service, and in other gatherings of the descendants of the clans, it is appropriate, and strongly encouraged, for members to wear the Scottish garb of their clans, and/or to obtain and display their clan's colors in a Tartan banner. According to Wayne Cousar's March 25, 2018 memo to the membership, the flag or Banner should match your clan tartan, and should be a 3 X 5 flag with a fringed

edge on the bottom, and a sleeve that will accommodate a 1 1/8" (one and one eighth inch) pole. (SALC has the poles already)

Two sources for the flags/banners, or for the tartan cloth if you wish to buy the material and have the flag made are:

There are other sources as well and as yet untried. It was duly noted that if your tartan does not match your clan tartan, it is a near certainty that there would be no repercussions, and more likely that no one would notice.

- 5. It was reported by the Exchequer that there is at least one new potential member in the pipeline.
- 6. It was agreed by those present that a means of recording and preserving the biographical information of our members and their ancestors will be undertaken going forward, thus honoring and preserving our ancestors memories, and enhancing the familiarity of all members with each other.
- 7. The fourth and final version of the Society by laws have been completed after considerable effort by Secretary Henderson, and approved by the committee. A copy is attached. Everyone is encouraged to review the bylaws, and to provide the committee, thru Secretary Henderson, any concerns or suggested changes. If no concerns or suggestions are received within a reasonable time, (ten days from the receipt of these minutes), then the by laws will be considered approved.

There being no further business, and it being time for rest and refreshments, the meeting was adjourned at 6:00 pm, approx..
